一、本規定係依據教育部頒「學位授予法」、本校「學則」及「研究生學位考試施行細則」訂定之。These rules are based on the Ministry of Education's "Rules on Degree Conferral" as well as National Sun Yat Sen University's "Student Rules" and "Graduate Student Examination Rules."

二、在學期間相關事項 Related rules for current students :

(一) 修業年限 Required years of study :

研究生修業年限一至四年(不含保留入學及休學期間)。

The required length of study is between one and four years, not including deferred admission and approved leaves of absence.

(二) 學分制度及修課要求 Credit system and course requirements :

1. 研究生須於入學後二學年內，修畢 24 學分課程（不含「書報討論」）與 2 學分「書報討論」課程。其中「專題研究」課程至多 3 學分得計入最低畢業學分數，

本校五學年學、碩士學位生，最多可抵免 18 學分課程，書報討論不得抵免。  
Students are required within two years of study to complete 24 credits, The requirement excludes 2 credits for “SEMINAR” of which the " INDEPENDENT STUDIES" course has at most 3 credits, which can be counted as the minimum graduation credits. For five years bachelor's-master's degree students, up to 18 credits can be deducted for courses, but literature discussion credits are not deductible.

2. 研究生修業時間未滿兩學年，若於學位考試通過後至最近之註冊日前未能完成離校程序者，必須續修一學期「書報討論」。If a student passes their degree examination before the end of the second year of study, but there is not enough time in the semester to complete their other graduation and leaving requirements, they must continue their studies for another semester with a “SEMINAR.”
3. 研究生因符合校內規定經推薦出國交換、研習課程或修讀雙聯學位者，經系務會議同意，得免修習原在校年級規定應修之「書報討論」課程學分。Students recommended for international exchange programs, enrolled in practical training studies, or dual degrees, with departmental permission are exempt from the requirement for “SEMINAR” credits.
4. 研究生須於每學期註冊日起一周內，列印本學期預計選修課程，請指導教授簽名同意後，送交系辦公室存查。

### 三、碩士學位考試：Masters Degree Examinations：

學期之定義：第一學期自每年八月一日至隔年一月三十一日、  
第二學期自每年二月一日至七月三十一日。

Semester period：Fall semester runs from August 1st until January 31st of the following year, and Spring semester runs from February 1st until July 31st.

#### (一) 論文計畫書審查 Masters Thesis Study Plan Review：

1. 研究生在提出學位考試申請前一學期 11 月 (4 月) 30 日前必須通過論文計畫書審查。審查方式口試行之，由指導教授提名並經主任同意之三位助理教授以上教師擔任口試委員，研究生需於口試前提交論文計畫書給口試委員，委員就計畫書與口試內容進行審查，半數以上通過為及格。One semester before applying for their Degree Examination, students must pass the Masters Thesis Study Plan Review process before 30<sup>th</sup> November (April). The review is in the form of an oral defense, and the committee will be composed of the advisor and three faculty members with a position of assistant professor or higher. The study plan must be submitted before the date of the oral defense to the committee members, and will pass review with the consent of half of the committee.
2. 更換指導教授者，學生須於更換日期六個月後再次進行一次上述論文計畫書審查程序。For students who change their advisors, they need to do the proposal again six months after the date of changing.

#### (二) 碩士論文考試 Masters Thesis Examination：

1. 在規定期限內通過論文計畫書審查之研究生，須於當學期 4 月(11 月)中旬前備妥打字論文初稿，經指導教授簽認，送至系辦公室。Students who have passed their Masters Thesis Study Plan Review must prepare a typed first-draft of their thesis by the April or November of that semester, and after it is approved by their advisor, send it to the department office.
2. 論文初稿由主任任命三位助理教授以上本系教師組成之小組進行審核。論文初稿經審核通過後，方得申請論文考試。未通過論文初稿審核者，不得於當

學期提出碩士論文考試申請。The first draft of the paper will then be reviewed by a committee selected by the department chair, composed of three faculty members from this department with a position of assistant professor or higher. After the first draft of the thesis has been approved, students can apply for their Masters Thesis Examination. Those who fail can not apply for their Masters Thesis Examination in that semester.

3. 碩士論文考試委員人選由指導教授依「國立中山大學研究生學位考試施行細則」規定提名，經主任同意後呈請校長核定聘任之。The student's advisor will select a committee for the Masters Thesis Examination in accordance with the "National Sun Yat Sen University Rules on Graduate Degree Examinations", and after the department chair's approval, the president will then approve and appoint the committee.
4. 研究生需於論文口試一星期前，完成論文原創性比對，論文在扣除引用部份與參考文獻後，「相似度」需等於或低於 12%。如「相似度」高於 12%，需將比對結果提交指導教授與口試委員審閱。口試委員需於研究生學位考試「論文考試」成績單，確認論文原創性比對結果通過，才能舉行論文考試。Students, one week before the oral defense of their dissertation, must complete verification of their authorship of the work, and excluding citations and references, the similarity to other works can not exceed 12%. If the dissertation exceeds this limit, the report will be sent to the Degree Examination committee, and the committee must confirm the student's authorship before they can pass the Degree Examination.

5. 碩士生擬申請「學位考試論文緩送」，該生之指導教授須填寫「論文成績緩送原因敘明表」，提交研究委員會審議後辦理。If students want to apply for delay submission of the defense grade, their advisors need to submit the "Explanation of the Delay Submission of Thesis Defense Grade for Master Students" to the research committee for approval.

四、畢業：符合上述之各項規定並通過碩士論文考試者，得提出畢業之申請，研究生辦理畢業離校時，需繳交「畢業論文之原創性報告」及「研究生學位論文符合學術倫理規範聲明書」，並由指導教授親簽後，繳交至系辦公室存查，方得畢業離校。Students who have completed all of the above requirements and passed their Masters Thesis Oral Defense can apply for graduation. They must submit their "Thesis Authorship Verification Report" and "Academic Ethics Thesis Compliance Verification Certificate," and have both signed by their advisor, and then sent to the department office. After checking, the student will be approved for graduation.

五、本規定經系務會議、院務會議通過，簽請校長核定後施行，修正時亦同。These rules will go into effect after having been ratified by the department and college, and signed by the university president, including all amendments.
